Project Title	Description*	Funded	Local Match	Total Project Cost
Carnation Ave Litter Removal Project	Install 3 continuous deflective separation units within this watershed to remove oil, grease, sediment and trash generated in and around Pacific Coast Highway	\$726,810	\$311,490	\$1,038,300
Big Canyon Restoration Wetlands Project	This project is designed to capture and treat 100% of the annual wet and dry weather runoff within the Big Canyon Watershed. Transportation related pollutants from Jamboree Road surface runoff currently flow directly to Big Canyon Creek and Upper Newport Bay during storm events. The dual system will also capture and treat a portion of the dry weather flows from Big Canyon Creek.	\$1,592,780	\$682,620	\$2,275,400
Bayview Heights Restoration/Mitigation Project	The proposed project will eliminate the future erosion by conveying flows in an underground storm drain which will outlet, via an energy dissipater, into constructed wetlands that will be designed to trap sediment and other constituents of concerns form the flow prior to discharge to bay. Eroded areas will be repaired and planted with native vegetation. Dry-weather and storm flow runoff from Mesa Drive and adjacent residential areas in Bayview Heights captures metals and other pollutants found in the streets and conveys these pollutants loads overland where it outlets into sensitive marsh and mudflats areas along Upper Newport Bay.	\$305,000	\$180,000	\$485,000
Corona del Mar Water Quality Improvement and Litter Removal Project	This project complements the City's upstream irrigation-upgrade program to reduce dry weather flow in Buck Creek and eliminate creek flows from flowing across the beach. This flow includes metals (copper, zinc, cadmium) and other pollutants.	\$250,000	\$110,000	\$360,000

On April 7, 2015, the State Water Resources Control Board adopted an amendment to the Water Quality Control Plan for the Ocean Waters of California to control trash (referred to as "Trash Amendments"). These Trash Amendments will address all water bodies in the state currently listed as "impaired" due to the presence of trash. The amendments will take effect following approval by the Office of Administrative Law and the US EPA (anticipated in fall 2015). An overview of the amendments will be provided.
