

## OCTA Bike Month Strava Contest – Official Rules

By participating in this promotion you, agree to the **Official Rules**

NO PURCHASE OR PAYMENT NECESSARY TO WIN

**Eligibility:** To enter, you must be at least 18 years of age, or have a parent or legal guardian’s permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

**Timing:** The “Bike Month OC” Strava Club begins at midnight on April 16, 2017 and ends on May 31, 2017 at 11:59 p.m.

### Contest

**How to Enter:** During the promotional period, go to [octa.net/BikeMonth](http://octa.net/BikeMonth) and download the Strava app. Once the app has downloaded, create an account, and join the “Bike Month OC” Strava Club. Upon joining the Club, you will receive one (1) entry into the Contest. Be sure to login to the app to track your miles with the GPS turned on. Rides will not be tracked if the GPS is turned off. **Limit:** One entry per person.

**Contest:** OCTA will award the first-place prize to the “Bike Month OC” club member who logged the most total distance on the club’s Leaderboard. The second-place prize will be awarded to the club member who logged the second-most total distance on the club’s Leaderboard. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Contest participants. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within fifteen (15) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

**Prizes:** Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged. The rider with the most miles will be awarded the Trek FX 2 and the second-place rider will be awarded the Fitbit Blaze at the end of the promotional period. Additional bike month gear may be given at random throughout the duration of the Contest.
