

## OCTA Bike Month Pledge Sweepstakes – Official Rules

### Sweepstakes

**How to Enter:** During the promotional period, go to [octa.net/BikeMonth](http://octa.net/BikeMonth) and complete the Pledge entry form. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes. **Limit:** One entry per person.

**Drawings:** OCTA will randomly select the potential winners from all eligible Sweepstakes entries received by the time of the drawings. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within fifteen (15) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

**Prizes:** Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged. One first prize and second prize winners will be selected at the end of the promotional period. Additional bike month gear may be given at random throughout the duration of the sweepstakes.
