Transit

- Bus Program
 - Sales tax revenue is forecasted to grow by 1.9 percent to \$231 million
 - Consistent level of fixed-route service hours to accommodate increased ridership
 - Total paratransit trips increased to accommodate potential increases in demand
- Rail Program
 - Metrolink service levels budgeted at 57 trips (41 weekday and 16 weekend)
 - Metrolink operating subsidy at 90 percent of pre-pandemic levels
 - Continued OC Streetcar construction

M2 Program

- Sales Tax Revenue
 - Forecasted to grow by 2.6 percent to \$462 million
- Expenditures
 - Freeway Mode expenditures in the amount of \$377 million, primarily driven by right-of-way, design, and construction efforts for State Route 55 (SR-55) Improvement, Interstate 405 Improvement, and South County Interstate 5 Improvement Projects
 - Streets and Roads Mode expenditures in the amount of \$185 million driven by contributions to the cities to support the Local Fair Share, Regional Capacity, and Traffic Signal Synchronization Programs
 - **Transit Mode** expenditures in the amount of \$120 million, primarily to support community-based transit circulators, senior mobility, regional rail, and construction of the OC Streetcar

Express Lanes

- 91 Express Lanes Assumptions
 - Trips anticipated at 19.5 million
 - Toll Revenues slightly decrease to \$49.2 million
- 405 Express Lanes Assumptions
 - Operational beginning in late 2023
 - Transaction counts are anticipated at 56 million through five ingress/egress
