**Drawings:** OCTA will randomly select the winner from all eligible Sweepstakes entries received by the time of the drawings. One (1) winner will be randomly selected by May 24, 2021. Winners will be announced by May 31, 2021 at 11:59 p.m. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of two (2) attempts will be made to contact the winners using the contact information provided. If the designated winners do not claim the prize within seven (7) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.
