The Orange County Transportation Authority is constructing the Placentia Avenue and Kraemer Boulevard undercrossings. Work is starting soon on the overcrossings at Orangethorpe Avenue and Tustin Avenue/Rose Drive. In accordance with federal railroad safety regulations, residents should expect to hear an increase in the frequency of train horns because of construction activities on and around the railroad tracks, regardless of quiet zone designation.

Regular work hours are Monday through Saturday, 7 a.m. to 8 p.m.

The following construction activities are anticipated to begin during the next two weeks:

Placentia Avenue

- Start excavation of roadway and shoofly embankment west of the bridge
- Continue structural, drainage and electrical/mechanical work for the Pump Station
- Continue work on Retaining walls Night work 8/21/13, 8/22/13, 8/23/13
- Continue work on Home Depot driveway

Kraemer Boulevard

- Continue constructing storm drain and sanitary sewer at retaining wall RW5
- Continue construction of site wall B1 masonry
- Continue construction of property side site walls
- Continue roadway excavation along Crowther

Orangethorpe Avenue

- Continue preconstruction submittal review process
- Boring of 72" casing to continue
- Storm drain work to continue next week
- Utility work:
 - 1. AT&T to continue splicing cable for new section of cable and conduit
 - 2. SCE will continue pulling wire to steel (TSP) poles
 - 3. SCE to pull wires over tracks on 8/21/13 Night work

Tustin Avenue/Rose Drive

- Install reinforcement for the foundations of abutment 1 and 2 and the north access road retaining wall of the bypass road bridge over Atwood Channel
- Continue excavation and installation of the Orange County Sanitation District 27" VCP sewer relocation in the utility corridor on the west side of Tustin Avenue
- Begin relocation of the existing 8" water line and meter vault at the new north entrance into Del Cerro Mobile Home Park off of Rose Drive. This work will require temporary water shutoff to Del Cerro residents on September 4 beginning at 8am for up to 8 hours
- Provide survey staking in the area of the Bypass road temporary BNSF RR crossing to allow BNSF personnel to perform field survey to develop final plan for crossing arm and signal locations
