

Construction Notification Week of April 1, 2019

Crews are continuing potholing activities along the project route, with work generally moving from west to east. Potholing activities include excavation, soil backfill, and road work and restoration. While potholing work is underway, community members can expect short, intermittent parking and lane restrictions.

Additionally, crews will begin sewer installation work, which includes excavation, trenching, installation of sewer pipelines, and road work and restoration. This work will require temporary parking and lane restrictions.

Access will be maintained for all residents and businesses.


SEGMENT 1 CONSTRUCTION ACTIVITIES

Intersection of Harbor Blvd. and Westminster Ave. to Raitt St.

Over the next two weeks, Segment 1 construction activities will include:

- · Preliminary work and demolition at the site of the future Maintenance Storage Facility
- Tree removal within the Pacific Gas & Electric Right-of-Way

Following project completion, trees will be replanted along the OC Streetcar alignment. More trees will be replanted than will be removed.




SEGMENT 2 CONSTRUCTION ACTIVITIES

Raitt St. to Parton St.

Over the next two weeks, Segment 2 construction activities will include:

• Street demolition and sewer installation from N. Raitt Street to N. Western Street

This work will generally move west to east and will require temporary lane and parking closures on W. Santa Ana Boulevard. Crews will close two eastbound lanes for approximately two block segments (beginning with N. Raitt Street to N. Western Street) and shift one eastbound lane to the north side of Santa Ana Boulevard. Please slow through the construction area and follow flaggers instructions. Advance notice will be provided to community members in the segment prior to the start of this work.



SEGMENT 3 CONSTRUCTION ACTIVITIES

Ross St. to Mortimer St.

Over the next two weeks, Segment 3 construction activities will include:

Over the next two weeks, Segment 4 construction activities will include:



About the Project

OC Streetcar is the first modern streetcar project to be built in Orange County and will serve Santa Ana's historic and thriving downtown, which includes federal, state and local courthouses, government offices, colleges, an artists' village and a thriving restaurant scene. Expected to begin carrying passengers in 2021, it will operate along a 4.15-mile route that connects the Santa Ana Regional Transportation Center (SARTC) and a new transit hub at Harbor Boulevard and Westminster Avenue in Garden Grove.
