

## OC Metrolink Ocean Festival Sweepstakes – Official Rules

By participating in this promotion, you agree to the **Official Rules**

### ***NO PURCHASE OR PAYMENT NECESSARY TO WIN***

**Eligibility:** To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

**Timing:** The Sweepstakes begins at midnight on June 21, 2022 and ends on July 6, 2022 at 11:59 p.m. All winners will be selected and announced by July 8, 2022.

### **Sweepstakes**

**How to Enter:** During the promotional period, go to [octa.net/OceanFestival](http://octa.net/OceanFestival) and complete the Sweepstakes entry form. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes.

**Limit:** One entry per person.

**Drawings:** OCTA will randomly select the potential winner(s) from all eligible Sweepstakes entries received by the time of the drawings. Ten (10) winners will be randomly selected at the conclusion of the campaign. OCTA staff will notify the potential winner(s) of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of two attempts will be made to contact the winners using the contact information provided. If the designated winners do not claim the prize within three (3) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

**Prizes:** Limit of one prize per participant. The winner will receive two (2) promotional roundtrip Metrolink tickets (total value: approximately \$110). Prizes are distributed at OCTA's discretion and can be substituted at any time.
