## Interstate 5 (I-5) South County Projects Update

## **Project and Public Outreach Update**



### I-5 from Avenida Pico to San Juan Creek Road


- Add one high-occupancy vehicle (HOV) lane in each
- Improve sight distance on southbound horizontal curve north of Pacific Coast Highway
- Reconstruct Avenida Pico interchange:
  - Widen northbound Avenida Pico on-ramp to three lanes
  - Provide dual left-turn lanes to both northbound and southbound Avenida Pico off-ramps
- Add soundwalls
- Approximately \$275 million from Measure M, federal, and state funding
- Construction scheduled to begin in late 2013

# I-5 from SR-73 to El Toro Road

- One general purpose lane each direction
- Extend second HOV lane from Alicia Parkway to El Toro Road
- Reconstruct Avery Parkway and La Paz Road interchanges
- Re-establish all existing auxiliary lanes
- Construct soundwalls as needed
- Approximately \$560 million from Measure M and federal funds
- Construction scheduled to begin in 2018 through 2022

## **Community Outreach Activities to Date**

#### Avenida Pico to San Juan Creek Road

- Presented to San Juan Capistrano, Dana Point, and San Clemente councils
- Held 13 briefings with local, state, and federal elected officials
- Conducted more than a dozen ascertainments with key stakeholders
- Spoke to 11 chambers, business groups, associations, homeowners associations
- Organized six neighborhood meetings in San Clemente; door-to-door outreach to 300 San Clemente residents
- Attended seven local community events
- Initiated proactive social / print media activities

#### SR-73 to El Toro Road

- Held 18 briefings with local, state, and federal elected officials
- Presented to three civic and business groups
- Conducting ascertainments now; will complete in early 2013
