Grade Separation Locations



OCTA Board of Directors (Board) and California Transportation Commission (CTC) Actions



- January 2008 OCTA applied for Trade Corridor Improvement Fund (TCIF)
- April 2008 CTC programmed \$182.8 million in TCIF funds
- July 2010 Board approved the OC Bridges Program budget adjustment for an increase of \$172.9 million



Board & CTC Actions (continued)



- November 2010 Board approved federalization of Raymond Avenue railroad grade separation project
- August 2011 Board approved replacement of \$43.6 million in Congestion Mitigation and Air Quality (CMAQ) funds with Proposition 1B – Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) funds for Raymond Avenue railroad grade separation project
- April 2012 Staff is requesting Board to amend the OC Bridges Program funding plan



Recommendations



- Reduce City of Fullerton's contribution by \$5.7 million
- No Net Increase of M Funds
- Add Burlington Northern Santa Fe Railway (BNSF) contribution as a revenue source
- Reprogram \$12.757 million in TCIF funds



Recommendations (continued)



- Reduce Regional Surface Transportation Program/ CMAQ funds by \$29.517 million
- Change PTMISEA Program expenditure plan by increasing amount from \$43.6 million to \$78.504 million
- Authorize staff to make necessary amendments to existing agreements


