A. Active Transportation Program Update

Peter Sotherland, Active Transportation Coordinator, presented the item.

Committee Member Comments:

A committee member asked how well attended the Ebike Rodeo in Laguna Niguel was. Peter responded the event was modestly attended and some attendees of a softball event next door attended. They are working within their constraints of different schedules and are trying to piggyback on existing events.

A committee member asked if there will be another round of grants for the Next STEP projects. Peter said it is a 3-year project, and all schools will be included upfront. The committee member asked for a point of contact for the smaller school districts and unincorporated areas. Peter said they will do jurisdiction-wide Safe Routes to School meeting to include representatives of all areas. He added that he will supply contact information.

A committee member asked if coordination is going well with the cities regarding e-bike regulations across the cities. Peter responded they want to be careful around the nuanced needs of each area while still trying to have consistent messaging and language. They are working on initiatives but there will not likely be a region-wide ordinance.

A committee member said eVTOLs will be around next year and wants to know if they are on the radar. Peter said they are always looking at first and last-mile connections but are not sure if that technology is something they are looking at specifically.
