- I-5, I-405 to SR-55 Design Phase
 - Segment 1 (I-405 to Yale Avenue) Release of request for proposals
 - Segment 2 (Yale Avenue to SR-55) Approval of consultant selection
- SR-91, SR-57 to SR-55 Design contract executed for Segment 3 (Acacia Street to La Palma Avenue).
- I-405, SR-73 to I-605 Over 50 percent complete and budget changes approved.
- I-605, Katella Avenue Interchange Design contract executed.

Approximately \$893 million provided to local jurisdictions to date:

- 143 street capacity improvement projects
- 117 signal synchronization projects
- Over \$475 million in flexible funding

Program Highlights - Transit



- \$215 million used to fund OC Metrolink service
- \$667 million invested in station and grade crossing improvements
- OC's first modern streetcar underway
- 26 community-based transit/circulators
- Over \$3 million allocated to improve 114 transit stops
- \$84.6 million allocated to expand mobility choices for seniors and persons with disabilities

Program Highlights - Environmental



Environmental Cleanup Program

- \$51.3 million allocated for 196 water quality improvement projects
 - 33 million gallons of trash captured (nearly 78 football fields with one-foot deep of trash) since inception

Freeway Environmental Mitigation Program

- 1,300 acres of open space preserved and 350 acres restored
- Receipt of biological and water quality permits streamlining freeway projects
- Endowment established to protect acquired lands in perpetuity.

 As of December 31, 2020, the balance of the endowment was \$17,664,006.

 Programming recommendations for 12 Tier 1 Projects totaling \$2.8 million.
