

OC Metrolink Weekends Sweepstakes and Photo Contest – Official Rules

By participating in this promotion you, agree to the **Official Rules**

Eligibility: To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

Timing: The Sweepstakes/Photo Contest begins at midnight on September 5, 2017 at 11:59 p.m. and is ongoing with weekly winners. Winners will be selected and announced weekly.

Sweepstakes

How to Enter: During the promotional period, go to octa.net/metrolinkweekends and complete the Sweepstakes entry form. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes. **Limit:** One entry.

Drawings: OCTA will randomly select the potential winners from all eligible Sweepstakes entries received by the time of the drawings. One (or more) winner(s) will be randomly selected each week throughout the duration of the promotion. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Limit of one prize per participant. Each winner will receive two (2) promotional round-trip Metrolink tickets.

Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.

Judging: OCTA staff will decide which photos will be deemed as winners. The number of winning photos will be determined based on the number and quality of acceptable entries. Staff may determine that only one or no winners will be selected if there are no worthy entries. Photos will be judged by their representation of Metrolink, as well as their originality and creativity. OCTA's decisions are final in all matters relating to this contest.

Prizes: No monetary prizes will be awarded for the contest. Winning photos (and possibly other entries) will be featured on octa.net and OCTA's social media pages during the promotion.

Release: By accepting a Sweepstakes or photo contest prize, participants agree to hold OCTA, sponsors, directors, officers, employees and agents (Released Parties) harmless against any and all claims or liability arising out of their participation in the promotion, redemption, or use of any prizes awarded. By participating in this promotion, entrants agree to be bound by the official rules and the decisions of OCTA.

General Conditions: OCTA reserves the right to cancel, suspend and/or modify the Sweepstakes/Photo Contest, or any part of it, if any fraud, technical failures or any other factor beyond OCTA's reasonable control impairs the integrity or proper functioning of the Sweepstakes/Photo Contest, as determined by OCTA in its sole discretion.
