

## **Construction Notification**

October 1, 2014

The Orange County Transportation Authority is building a series of bridges to separate trains from vehicles along the BNSF corridor in Fullerton, Placentia and Anaheim. In accordance with federal railroad safety regulations, residents should expect to hear an increase in the frequency of train horns because of construction activities on and around the railroad tracks, regardless of quiet zone designation.

Regular work hours are Monday through Saturday, 7 a.m. to 8 p.m.

#### Tustin Avenue/Rose Drive Overcrossing

In order to open the bypass road for the Tustin / Rose Drive project on Sunday morning by 6 am, BNSF crews will close four intersections along the railroad tracks: Tustin/Rose, Van Buren Street, Richfield Road and Kellogg Drive starting Saturday evening, October 4, between 6 pm and 6 am. Drivers will be directed to use Jefferson Street or Lakeview Avenue as alternate routes. Train operators may use their horns during the operation.

Once completed, the bypass road will be opened, connecting Tustin Avenue across Orangethorpe Avenue to Del Cerro Drive and then to Rose Drive. Please drive safely; we appreciate your continued patience.

#### State College Boulevard Undercrossing

On October 14, State College Boulevard will be reduced to one lane in each direction from approximately 500 ft. south of Kimberly Drive to Valencia Drive. Drivers are encouraged to use either Acacia Avenue or Placentia Avenue as alternative routes. Portable changeable message signs will be activated prior to the lane reductions, and detour signs will be visible to assist drivers. Access to driveways for businesses within the impacted area will remain open. These lane reductions will continue throughout the rest of the year. A full closure of State College Boulevard is planned for January 2015. Additional information will be provided at a later time.
