

OC Metrolink Swallows Day Sweepstakes – Official Rules

Limit: One entry per person

Drawings: OCTA will randomly select the potential winner(s) from all eligible Sweepstakes entries received by the time of the drawings. Ten (10) winners will be randomly selected at the conclusion of the campaign. OCTA staff will notify the potential winner(s) of their prize via the email address provided to OCTA by the Sweepstakes participants. A minimum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.
