

OC Metrolink Spring Campaign Sweepstakes – Official Rules

By participating in this promotion, you agree to the **Official Rules**.

Eligibility: To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents, and their immediate family members are not eligible.

Timing: The Sweepstakes begins on April 5, 2023, and ends on June 30, 2023, at 11:59 p.m. One winner will be selected at the end of each month. For April, the winner will be selected and announced by May 15; for May, the winner will be selected and announced by June 15; and for June, the winner will be selected and announced by July 15, 2023.

How to Enter: During the promotional period, go to MetrolinkWeekend.com and complete the Sweepstakes entry form. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes. Limit: One entry.

Drawings: OCTA will randomly select the potential winners from all eligible Sweepstakes entries received by the time of the drawings. One (1) winner will be randomly selected each month during the campaign for a total of three (3) winners, one winner each month for the three-month campaign. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participants. A maximum of two attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Limit of one prize per participant. Each winner will receive two (2) promotional roundtrip Metrolink tickets (valued at \$110) and a \$100 gift card. Prizes are distributed at OCTA's discretion and can be substituted at any time.
