



## **Orangethorpe Transit Village Conceptual Study Sweepstakes Official Rules**

**Eligibility:** To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

Box 14184, Orange, CA 92863-9831. Upon submission of your online registration form, or receipt of your mailed form by OCTA, you will receive one (1) entry into the Sweepstakes.

**Limit:** One entry per person. The first entry received will be entered into the Sweepstakes. Any subsequent entries received from the same person will not be counted.

**Drawings:** OCTA will randomly select the potential winner from all eligible Sweepstakes entries. Two (2) winners will be randomly selected at the conclusion of the campaign. OCTA staff will notify the potential winners of their prize via the email address provided to OCTA by the Sweepstakes participant. A maximum of two (2) attempts will be made to contact each winner using the contact information provided. If the designated winner does not claim the prize within three (3) days of the date of the last attempt of contact, that winner shall forfeit receipt of the prize.
