Once an approval notice is received, applicants can come to the OCTA Store Monday through Friday between 8AM-5PM with a valid ID card to pick up their ID Card. If an application is denied, the applicant will receive a written notification that will include the reason(s) for denial. Applicants may then correct applications or appeal denial of eligibility within 14 days of the date of denial notice.
